
MOVANT'S AFFIDAVITS AND EXHIBITS



AFFIDAVIT OF KIRK BECK

NOW COMES KIRK BECK, being of legal age and duly sworn according to law and deposeth and sayeth as follows:

1.) Affiant at all times relevant to this Affidavit was an employee of Horizon Propane, in whose employ affiant held the position of head manager of field supervisors. Affiant says further that twelve (12) field supervisors reported directly to him.


2.) Affiant says further that on or about April 1, 2003 he, along with the other field managers, was sent a work order by Roni Ziska, another Horizon Propane employee. The said work order provided by its terms that each field manager was to purchase paint from the Sherwin-Williams retail location in each of the managers' respective areas sufficient to repaint the 30,000 gallon storage vessels at the Horizon Propane distribution sites. The work order further provided a particular code number for the paint color that was to be purchased.

3.) Affiant says further that he and the other managers perceived that this work order was strange because the 30,000 gallon storage vessels were already painted with a light gray. Repainting each tank would require 10 gallons of paint in order to coat it, at a very high cost per gallon not to mention the labor.

4.) Affiant says further that this work order, requiring that each of the storage vessels be painted "**Amerigas White**," convinced the field managers, as a consensus, that Amerigas was already in control of Horizon Propane, despite the fact that the auction of Horizon Propane as a going concern was to be held months later. It was further the


consensus of the field managers that the bankruptcy was a fraudulent devise to give Amerigas control of the former Level Propane.
