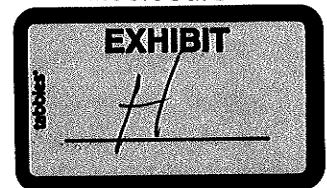





Withdraw as Counsel of Record.


Upon consideration of the facts and as no Objection was filed with the Court this
